

Report on feedback analysis (Students) - Session 2020-21


The students are the most important stakeholders of Higher Education system. Their feedback plays a significance role in the revision and updation of the curriculum. Analysis of the student feedback for the year 2020-21 brought about the following observations.

- Most of the students have the opinion that the syllabus is relevant and up-to-date. 37% responded excellent, 53% students responded good, and 10% responded satisfactory.
- Majority of the students rated excellent 47%, good 42% and 10% rated satisfactory for the parameter of timely completion of the syllabus by the faculty members.
- As far as the quality and quantity of the syllabus and learning materials were concerned, 48% students marked it good, 42% marked it excellent and 11% marked it satisfactory.
- In response to rating of the course content encouraging self-learning and extra learning, 52% responded good, and 40% responded excellent and rest of the 8% responded satisfactory.
- 55% students responded good and 35% excellent and 10% satisfactory in terms of sufficient books and reference materials available
 for the topics mentioned in the syllabus.

Report on Feedback Analysis (Alumni) - 2020-21

In order to make the academic environment of the college more student centric, the college gathers feedback also from Alumni. The college incessantly involves the past students to come forth and share their concerns. Since the students are the fundamental stakeholders of an academic institution, their experiences on Academic resources, Infrastructure, Extra-curricular activities etc. is gathered from the students. The collected and compiled responses is in quantitative terms. The students have marked their experiences on a 4- point scale (excellent, good, satisfactory and unsatisfactory). Feedback received from the alumni was analyzed and the conclusions were drawn.


- Regarding the infrastructure of the college, 44% responds for excellent, 33% good, and 22% were in satisfactory.
- As far as the basic amenities and the clean & green environment availability, 11% of the Alumni marked for excellent, 89% for good.
- Regarding extra-curricular and academics for the overall development of the alumni, 11% respondents said it is excellent, 55% said good and 33% said satisfactory.
- In the context to the role of valuable guidance given by the teachers, 33% remarked excellent, 44% good and 22% satisfactory.
- Regarding response of the college after the students passed the degree program, 22% respond excellent, 67% good and 11% satisfactory.





Report on Feedback Analysis (Faculty) - 2020-21:

The faculty feedback form consisted of five question related to course and curriculum prescribed by the university. Given below are the conclusions obtained by analyzing the faculty feedback for the academic year 2020-21.

- The syllabus is outcome based in the opinion of 52% of the faculty.
- 63% faculties agreed with the statement that the computer facilities are made available for ICT based teaching to the teachers.
- 74% faculty members agreed that the syllabus covers the cross cutting issues like gender equality, environment sustainability etc.
 and students are sensitized towards these issues.
- Courses in the curriculum promote entrepreneurship and students are encouraged and supported in the opinion of 63% of the faculty.
- There is an agreement (68%) to the statement that the college vision, philosophy & objectives are in the tune with Govt. Policies and reflected in college decisions.
