As per the order of the Principal, vide Letter No. TP-32/M(RLD)/NCW-2020 Dated 16.12.2020, the members of Women Grievance Cell attended a meeting organized by National Women Commission on 23/12/2020. In the meeting, it was instructed to transform the "Women Grievance Cell" into "Internal Cell." It was stated that the Internal Cell will be monitored by the National Women Commission. The Cell should constitute the nominated members from Judiciary and Police Department.

A meeting was called by the Convener of the Internal Cell on 31<sup>st</sup> of Dec as on 29<sup>th</sup> of Dec 2020, the Internal Cell had received a complaint by the girl-students of the college regarding the misbehavior of the vendors outside the college-gate. The fruit-sellers outside the college –gate. The fruit-sellers, vendors with their stalls outside the college-gate pass objectionable remarks /comments which make girl-students uncomfortable.

In the meeting the following points were put forward:

1. Since the vendors are not under the jurisdiction of the college, the matter may be reported to the police-station.
2. The committee decided to consult the matter with the Principal who may further the process of registering complaint in the nearest police-station.

On 07/01/2021, a workshop was conducted by the Internal Cell on “Legal Literacy” under the chairmanship of Hon. Principal Dr D C Nainwal.

Hon. Secretary and Civil Judge, District Judicial Services, Dehradun Neha Kushwaha was the Chief Guest and also the Chief Speaker. The workshop was attended by members of the Student Union, Faculty-members, Staff-members and Students. A total number of 71 students attended the workshop.
