Considering that the Memorandum of Understanding, Clause C, Areas of
collaboration, sub-clause 2.f, approved the establishment of the **Centre of

P.G. COLLEGE DOIWALA, DEHRADUN** and authorised head of Organisations to
sign the corresponding agreement.

Desirous of defining the terms and conditions governing the framework for
cooperation with DRONACHARYA UNMANNED AEROSPACE INNOVATIONS
(DUAL) that shall be granted to the centre of excellence in Drone technology
(COEDT) in this agreement.

HAVE AGREED AS FOLLOWS

Article 1-Definitions

1. In this agreement, "College" refers to "S.D.M GOVT. P.G. COLLEGE
DOIWALA, DEHRADUN".
2. "DUAL" refers to "DRONACHARYA UNMANNED AEROSPACE
INNOVATIONS".
3. The "Centre" means, "Centre of Excellence in Drone Technology".

Article 2- Establishment

College shall agree to take, in the course of the year Three and Two more year (Extendable), any measures that may be required for the set up on its territory of the Centre of Excellence in Drone Technology under the auspices of DUAL as provided for under this agreement.

Article 3- Purpose of the Agreement

The purpose of this agreement is to define the terms and conditions governing collaborations between College and DUAL concerned and also the rights and obligations stemming there from for the Parties.

Article 4- Legal status

- 1.1 The Centre shall be independent of DUAL.
- 1.2 The College ensure that the Centre enjoys within the territory the functional autonomy necessary for the execution of its activities and legal capacity:
 - To operate and to contract.

Article 5- Constitutive Act

The constitutive act of the centre must include provisions describing precisely:

- a. The legal status granted to the Centre, within the institution's legal system/ rules and regulations, the legal capacity necessary to exercise its functions and to receive funds, obtain payments for services rendered, and acquires all means necessary for its functioning.
- b. A governing structure for the Centre allowing College & DUAL representation within its governing body.

 - v. Supporting innovative proposals and ideas from students in terms of functions and facilities.
 - vi. Developing relations across states, between governments, industrial associations, institutions and experts for establishing collaborations of various research and commercial projects of organisations.
 - vii. Generating revenue through consultancy projects like customised drone development, component manufacturing, surveillance, aerial survey and mapping etc. by strengthening the capabilities of the Centre.
 - viii. Establishing an Entrepreneurship cell and thereby supporting the student and faculty start-ups.
 - ix. Conducting various technical Lectures / events to exhibit the talents of students.

Article 7- Governing Board

1. The Centre shall be guided and overseen by a Governing Board renewed every three years and include:
 - a. Principal of the College.
 - b. Co-ordinator of the Drone Technology programme.
2. The Director of the Centre for excellence duly appointed and agreed by both parties.

 - f. Up to three representatives of non-governmental organisations/ industries operating in this field.
2. The Governing Board shall:
- a. Approve the long term and medium term programmes of the Centre.
 - b. Approve the annual work plan of the centre, including the staffing table.
 - c. Examine the annual reports submitted by the director of Centre.
 - d. Examine the periodic independent audit reports of the financial statements of the Centre and monitor the provision of such accounting records necessary for the preparation of financial statements.
 - e. Decide on the participation of regional institutions/organisations in the world of the Centre.
 - f. Meet in ordinary session at regular intervals, at least once every calendar year.
 - g. Meet in extraordinary session if convened by its Chairperson, either on his/her own initiative or at request of the Director of Centre or of a majority of members.
 - h. Adopt its own rules of procedure of operation.

Article 8- COLLEGE'S contribution

1. The College shall provide all the necessary support, needed for the administration and proper functioning of Centre.
2. The College undertakes to:
 - a. Make available to the Centre adequate and accessible physical facilities for the pursuit of its activities.
 - b. Make available to the Centre the technical and administrative staff necessary for the performance of its functions, which shall comprise:
 - c. Organising the governing board, Executive Committee cover all associated

Article 9- DUAL OF COMAPNY'S contribution

1. DUAL may provide assistance, as needed, in the form of technical assistance for the programme activities of the Centre, in accordance with the strategic and objectives by:
 - i. Provide adequate technical consultancy services for the creation, maintenance and conduct all operations of the Centre.
 - ii. Assist in R&D activities in the Centre and all its projects.
 - iii. Provide all support in taking the developed products to the market.
 - iv. Provide all specialised Short/Long terms Drone courses which can be bear by students only.

Article 10- Participation

1. The Centre shall encourage all participation of other companies/organisations/industries which, by their common interest in the objectives of the Centre.
2. Sister concern companies of DUAL wishing to participate in the Centre's activities, as provided for under this Agreement, shall send to the Centre notification to this effect. The director shall inform the Parties to this Agreement of the receipt of such notifications.

Article 11- Utilization of Facilities

The Centre may be entitled to utilise the facilities and infrastructure available in College, present outside the Centre's premises with the prior approval from the head of institution to execute the undertaken research works or consultancy projects.

Article 12- Responsibility

As the Centre is legally separate from DUAL, the latter shall not be legally responsible for the acts or omissions of the Centre, and shall also not be subject to any legal process, and/or bear no liabilities of any kind, be they financial or otherwise, with the exceptions of the provisions expressly laid down in this

Article 14- Using DUAL and logo

1. The Centre may mention its affiliation with DUAL. It may therefore use after its title the mention "under the auspices of DUAL" or any part of DUAL associated branding acceptable to DUAL.
2. The Centre is authorised to use the DUAL and College logo or a version therefore on its letter headed paper and documents including electronic documents and web pages in accordance with the conditions established by the governing bodies of DUAL.

Article 15- Entry into force

This Agreement shall enter into force, following its signature by the Parties, when they have informed each other in writing that all the formalities required to that effect by the rules and regulations of College and by DUAL internal regulations have been completed. The date of receipt of the last notification shall be deemed to be the date of entry into force of this Agreement.

Article 16- Duration

This Agreement is concluded for a period of Three years as from its entry into force. The agreement shall be renewed upon common agreement between the Executive Board made its comments based on the results of the renewal assessment provided by the Director of Centre.

Article 18- Revision

This agreement may be revised by written consent between the DUAL and College.

Article 19- Settlement of disputes

1. Any dispute between DUAL and College concerning the interpretation or application of this agreement, if not settled by negotiation or any other appropriate method agreed to by the Parties, shall be submitted to final discussion to an arbitration tribunal composed of 3 members, one of whom shall be appointed by the College, another by the DUAL, and a third Who shall preside over the tribunal, shall be chosen by the first two.
2. The tribunal decision shall be final.
